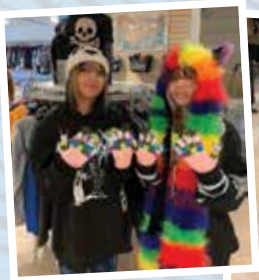




# 2023 ANNUAL REPORT



## Dear Friends,



In September, Clothes To Kids of Denver celebrated its 15th anniversary as a nonprofit serving Denver-area children and youth who are in need or in crisis. Since its inception, Clothes To Kids has distributed more than 104,000 wardrobes totaling over 2.1 million pieces of clothing. The photos of students excited about their new clothing in this annual report represent just a small fraction of the people positively impacted by the work of Clothes To Kids this year alone – now multiply that by 15! We are proud of all we have accomplished and grateful to everyone

who has contributed to Clothes To Kids' success to date.

But behind this milestone anniversary lies the stark reality of the continued, profound and immediate demand for our services. Clothes To Kids provided a record number of wardrobes in 10 out of the 12 months of 2023 and ended the year distributing 12,807 wardrobes – a 17% increase over 2022. With the arrival of so many newcomers, as well as our community's high cost of living, Denver-area students needed our services in 2023 more than ever. And while we do not have a crystal ball, we believe the demand for our services will continue to grow in 2024. We are equally confident that we will continue to meet the increased demand in the coming year and realize our vision of “ensuring all students have the clothing they need to feel comfortable, confident and prepared to thrive.”

Clothes To Kids could not do this important work without each of you! We are indebted to our four founders who dreamed of what this organization “could be,” and we are grateful to them, our generous donors, loyal volunteers, dedicated staff, devoted board of directors and terrific community partners who have all contributed to make Clothes To Kids what it is today. With your continued generous support, we will clothe children and change lives for many years to come.

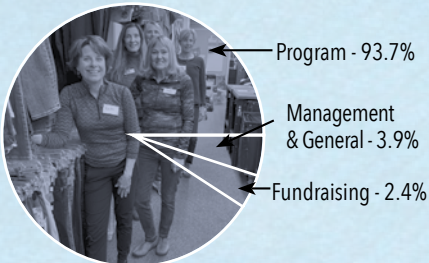

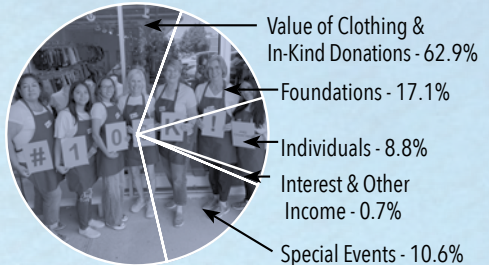


## 2023 Financial Results
